Sheldon Barr CEO South Bay Hospital

Sheldon Barr is the Chief Executive Officer of HCA West Florida Division's South Bay Hospital in Sun City Center, Florida. Immediately prior to joining South Bay Hospital she served as Chief Operating Officer at HCA Capital Division's Chippenham Hospital in Virginia, a Level I trauma center, 466-bed facility, and a campus of Chippenham & Johnston-Willis Hospitals.

Ms. Barr will discuss her experiences during the assumption of the leadership role at South Bay Hospital. She will detail some of her experiences in taking over the role of CEO.
